HISTORY OF AGC

GREATER DETROIT CHAPTER, INC.

In 1916, a group of contractors representing 10 area firms joined together and became the General Builders' Association of Detroit. These industry leaders realized the need for an effective organization to promote the common interests of those in the construction industry, and to establish guidelines for ethical business conduct.



Several members of this newly created Association also recognized the potential value of a nationwide organization, and were instrumental in the establishment of the Associated General Contractors of America, Inc., founded in 1918 in Washington, D.C. and today headquartered in Alexandria, VA. The organizational structure of AGC of America provides for autonomous local chapters with full-time staff to implement directives of its directors and committees, with personnel to keep local chapters abreast of current national events and to work at the national level for the benefit of members.

AGC of America represents over 7,200 firms, organized into 100+ local chapters throughout the fifty states and Puerto Rico, and is recognized as the authority in construction-related matters. The official motto of the AGC, which has been incorporated into its red and black emblem, is "Skill, Integrity and Responsibility." These three words best represent what it takes to be an AGC member.

In 1946 the General Builders' Association of Detroit changed its name to AGC, Detroit Chapter, Inc. In 1992, the Association added the adjective "Greater" to its name to more accurately reflect the Chapter's service area. Benefits to member firms throughout the years have justified the decision of the General Builders' Association of Detroit, now the AGC, Greater Detroit Chapter, Inc., to be a founding member of AGC of America.

Long ago the Greater Detroit Chapter adopted a long-range philosophy – a philosophy to promote the well-being of the public and a healthy construction industry based on the essential concepts of quality, efficient operation and responsible management.

Participation of member firms is fundamental to all progress the AGC has ever made or can ever hope to make. AGC staff regards service to the members as its foremost responsibility. This endeavor guides us in all activities.

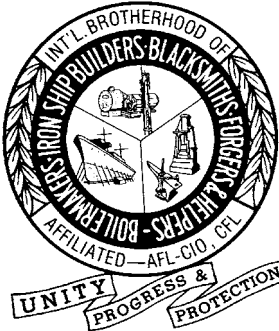

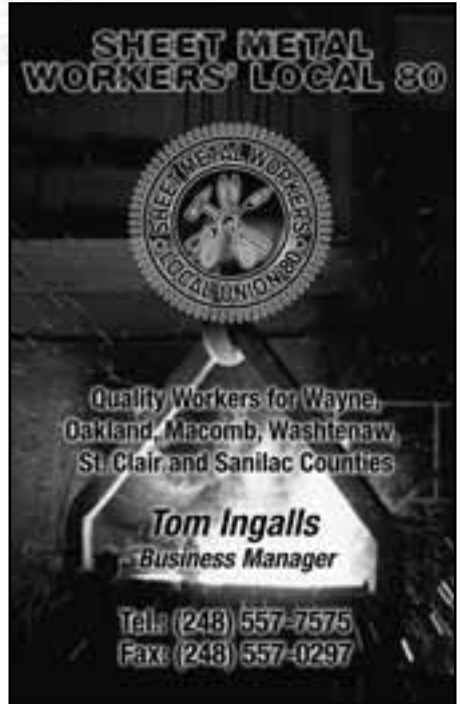
